

\$5000 CHRISTMAS GIVEAWAY

OFFICIAL RULES & LEGAL DISCLOSURES

These Official Rules govern the Linda's Way \$5,000 Holiday Giveaway ("Promotion"). By submitting a nomination or accepting the Prize, all participants agree to be bound by these Official Rules and the decisions of Linda's Way, Inc., which are final and binding in all matters related to this Promotion.

1. Eligibility

The Promotion is open only to families currently affected by cancer residing in the fifty (50) United States or the District of Columbia. Nominators may submit on behalf of a family, and self-nominations are permitted. Employees, board members, and immediate family members of Linda's Way, Inc. are not eligible to receive the Prize. Sponsor reserves the right to verify eligibility at any time. Void where prohibited.

2. How to Enter

To enter, a nominator must submit a complete nomination form during the Promotion Period, between 12:00 PM EST on November 28, 2025, and 11:59 PM EST on December 17, 2025. Each nomination must include accurate contact information and a written statement describing the family's circumstances. Entries that are incomplete, fraudulent, tampered with, or submitted outside the Promotion Period will be void. Limit one (1) nomination per family; No purchase or payment is required to enter or win.

3. Selection and Verification

All eligible nominations will be reviewed by a designated Linda's Way Review Committee. The committee will evaluate entries based on financial need, the impact of cancer on the family, clarity of the nomination, and the ability to verify the information provided. The family with the highest overall evaluation score will be selected as the potential recipient. Sponsor may request supporting documentation to confirm diagnosis, identity, residence, and need. Failure to provide requested verification within the required time may result in disqualification and selection of an alternate recipient.

4. Prize

One (1) selected family will receive a financial award in the amount of Five Thousand U.S. Dollars (USD \$5,000). The Prize will be issued via cashier's check, bank transfer, or other certified payment method determined by Sponsor. No substitution, transfer, or assignment of the Prize is permitted. Sponsor is not responsible for any taxes, fees, or obligations that may result from accepting the Prize; the recipient is solely responsible for any applicable tax reporting.

5. Winner Notification

The Potential Winner will be contacted privately on December 19, 2025, using the contact information provided on the nomination form. If the Potential Winner does not respond within twenty-four (24) hours, is deemed ineligible, fails to verify, or declines the Prize, the Sponsor may, at its sole discretion, select an alternate recipient. The Winner will be announced on or about December 19, 2025, subject to the family's consent to public disclosure.

6. Consent and Publicity

By accepting the Prize, the Winner permits Sponsor to use their name, story, general location, and likeness for promotional purposes in all media, without further compensation, unless prohibited by law. Families may request limited anonymity; however, the Sponsor may still be required to disclose certain information for legal or reporting purposes.

7. Limitation of Liability

By participating, nominators and nominees agree to release and hold harmless Linda's Way, Inc., its officers, directors, employees, volunteers, and affiliates from any liability, claim, loss, or damage arising out of participation in the Promotion or acceptance, possession, or use of the Prize. Sponsor is not responsible for lost, late, misdirected, or technical failures of any kind, or for any unauthorized human intervention.

8. General Conditions

Sponsor reserves the right, in its sole discretion, to cancel, suspend, or modify the Promotion if fraud, technical failures, or any other factor impairs the integrity or proper functioning of the Promotion. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. All federal, state, and local laws apply.
